**1. ATTENTION ALL PROVIDERS**

Below are the check run dates for the holidays through the end of the year:

- Thanksgiving Week - the weekly check run will be executed on Wednesday, **November 21, 2018**; paid dates will be Tuesday, **November 27, 2018**.

There will be no check run on Friday, **November 23, 2018**.

- Christmas Week - the weekly check run will be executed on Friday, **December 21, 2018**; paid dates will be Wednesday, **December 26, 2018**. **These will be the final paid dates of 2018.**
- There will be no check run on Wednesday, **December 26, 2018**, due to internal processing.
- New Year's Week - the weekly check run will be executed on Friday, **December 28, 2018**; paid dates will be Wednesday **January 02, 2019**.
